APPLICATION INSTRUCTIONS

These instructions are intended for governmental entities, British Petroleum and its contractors making emergency permit application requests pursuant to the Florida Department of Environmental Protection Emergency Final Order (EFO) OGC No. 10-160 for proactive measures, restoration, and certain other measures made necessary by the Deepwater Horizon Oil Spill.

DEP Form 73-303 is to be used for all requests made pursuant to the EFO for authorization to conduct regulated activities seaward of a Coastal Construction Control Line (CCCL) as established by law. The application must be received by the Department prior to expiration of the EFO in order to be considered and processed under the emergency procedures.

NOTE: DEP Form 73-303 contains information requirements that were developed for post-storm activities; therefore, some of those requirements are not directly applicable to oil spill response activities. Directions for completing DEP Form 73-303 follow.

Application Item #:

1. Complete the Owner and Agent sections as applicable.
2. A signature of the owner, governmental entity or responsible party authorizing the work and the Agent requesting the permit is required, along with the date.
3. A brief description of the work is required. Information such as a Florida Division of Emergency Management Mission Number(s) associated with the work is requested, if available.
4. Detailed ownership information per rule section 62B-33.008(3)(c), Florida Administrative Code, is not required for work conducted on public lands or seaward of an established Erosion Control Line.
5. In lieu of the stated requirement for written evidence of local approval, a statement of project consistency with the National Contingency Plan, Area Contingency Plan or Local Area Plan under the National Response System is required.
6. Survey information is waived with the exception of, at minimum, sufficient topographic or profile data required to evaluate projects that propose to alter existing beach grades or cause excavation of dune features. Surveys must include, at minimum, horizontal and vertical benchmarks and DEP Range Monument locations.
7. A site plan schematic is required, drawn legibly and to scale. The schematic must represent the work activities and work limits in respect to the CCCL, water line, vegetation line and major features such as roads, parks and beach access points.
8. A grading plan schematic is required for those applications that propose grade changes or excavation as described in Item 6, and may be combined with the site plan schematic.
9. Schematic cross sections are required specifically where Items 6 and 8 apply.
10. Construction schedule must include anticipated dates, timing for activity triggers, and time of day for all proposed activities. Emergency Permits are valid only for 90 days after permit issuance but may be extended pursuant to s. 62B-33.014, F.A.C.
11. Provide any previous or related CCCL permit numbers, if any (likely not applicable for this EFO).
12. Provide photographs (with dates and locations) of the project site, if available.
13. Not Applicable.

NOTE: The Department may require the Applicant to provide other site-specific information or calculations as may be necessary for proper evaluation of the application. Conversely, if certain of the above submittal items will require excessive time or expense to produce, a statement justifying deferral or elimination of those item(s) should be provided with the application.
