**FLORIDA POWER & LIGHT COMPANY'S**  
**STATUS REPORT**

Florida Power & Light Company (FPL), pursuant to the State of Florida Department of Environmental Protection's (DEP) Motion to Alter Schedule and Place Case into Abeyance, dated January 29, 2010, hereby files this Status Report and states as follows:

(1) Pursuant to the Florida Public Service Commission's Order No. 09-0715-FOF-EI, FPL was directed "to renew its request for proposals to fulfill its gas transportation capacity needs." (Page 6, PSC Order No. 09-0715-FOF-EI) Specifically, the PSC Order required that FPL's new RFP contain a specific, detailed request for proposals for a new pipeline, and specifications of the long term natural gas needs of FPL. Id.


(2) In response to the PSC Order, FPL is currently evaluating load growth, economic impacts, population growth, and other factors that relate to FPL's natural gas transportation requirements and its development of an RFP to meet those requirements. As of today's date, as we continue to evaluate these factors, FPL does not have an established timeframe for the RFP process.

(3) As required in Judge Canter's Order Altering Time Limits, Canceling Hearing, and Placing Case in Abeyance, dated February 1, 2010, the DEP shall inform

the Judge in writing by February 4, 2011 of the status of the case. Therefore, FPL hereby agrees to file a second Status Report to DEP prior to February 4, 2011 in order to inform DEP of FPL's progress.
